1. FEE & DEPOSIT

Total artist fee: USD \$[_____], exclusive of travel & accommodation. Fifty percent (50%) non-refundable deposit due on execution; balance due in full on or before the performance date by wire to [ACCOUNT DETAILS]. Cash balances, if any, paid to Management before performance.

2. TRAVEL & ACCOMMODATION

Purchaser provides and pays for all travel (international and local), accommodation, ground transport, and per diems for the full travelling party per the attached Hospitality Rider, in addition to the artist fee.

3. VISAS & WORK PERMITS

Purchaser is responsible for securing and paying for all visas, work permits, and immigration clearances required for Artist and the full travelling party, and for issuing timely letters of invitation and any documentation required by the relevant authorities. Failure to secure same is not a default by Artist.

4. RIDERS

The attached Technical & Artist Rider and Hospitality Rider are incorporated by reference and are the responsibility of the Purchaser. Selected tier options govern scope.

5. BILLING & PROMOTION

Artist to receive [headline / as agreed] billing. Purchaser may use Artist's approved name, likeness, and materials solely to promote this engagement; no product/brand endorsement implied without written consent.

6. RECORDING & BROADCAST

No audio, video, streaming, or broadcast of the performance without Artist's prior written consent.

7. MERCHANDISE

Artist retains 100% of merchandise rights and income unless a venue rate is agreed in writing. RMG Merch Drop Series terms, where applicable, per separate schedule.

8. CANCELLATION

If Purchaser cancels, deposit is forfeit; cancellation within [30] days of the date obligates the full fee. If Artist cancels other than for force majeure, deposit is refunded.

9. FORCE MAJEURE & WEATHER

Neither party is liable for failure due to events beyond reasonable control. For outdoor shows, Purchaser ensures a safe covered stage; Artist need not perform where safety is compromised, without loss of fee.

10. INSURANCE & INDEMNITY

Purchaser maintains public liability insurance for the event and indemnifies Artist and Management against claims arising from the event, save for Artist's gross negligence.

11. TAXES

Any withholding tax is [grossed up by Purchaser / handled per treaty with documentation]. Purchaser provides tax paperwork in advance.

12. RESPONSIBILITIES

Purchaser: venue, production, riders, travel, accommodation, visas, security, insurance, permits, marketing.
Management/Artist: performance, travelling-party manifest, advance cooperation, approved promo assets.

13. GOVERNING LAW

This Agreement is governed by the laws of [JURISDICTION]. Disputes resolved by [venue/arbitration].
